## HEARINGS ON THE REQUEST FOR PROVISIONAL MEASURES IN RESPECT OF THE M/V "SAIGA" TO BE HELD ON 23 AND 24 FEBRUARY

HAMBURG, 19 February. Public sittings in the case concerning the request for the prescription of provisional measures (*Saint Vincent and the Grenadines v. Guinea*) will open at 10.00 a.m. on Monday, 23 February 1998. The hearings will be held in the Great Hall of the City Hall of Hamburg. The hearings on Monday are expected to last until 6.00 p.m. A second round of hearings is scheduled for Tuesday, 24 February, starting at 2.00 p.m. until 6.00 p.m. In each round, the Tribunal will hear Saint Vincent and the Grenadines first followed by Guinea.

The Request is for Guinea not to interfere with the freedom of navigation and related rights of Saint Vincent and the Grenadines. It further requests that Guinea immediately comply with the Judgment of the Tribunal of 4 December 1997, in the M/V "SAIGA" case. In a reply filed on 13 February 1998, Saint Vincent and the Grenadines revised its request to include a prohibition for Guinea to undertake hot pursuit of vessels other than as authorized under the United Nations Convention on the Law of the Sea.

In its response filed on 30 January 1998, Guinea asked the Tribunal to reject the request by Saint Vincent and the Grenadines.

Further details concerning the case are contained in previous Press Releases of the Tribunal Nos. 8, 9, 10 and 11.

The 21 Judges of the Tribunal have assembled in Hamburg on Monday, 16 February 1998, to commence the case and also the Fifth Organizational Session of the Tribunal. The Fifth Session, which was originally planned to start in March, was advanced in order for it to coincide with the deliberations in the case on the provisional measures.

The Judges will, in accordance with Article 3 of the Resolution on the Internal Practice of the Tribunal and Article 68 of the Rules of the Tribunal, be meeting in private to exchange views concerning the written pleadings and the conduct of the case. During these deliberations, the Judges will identify what matters need clarification and whether any additional evidence or documents should be presented.
